Certification Marks

In order to establish a high level of assurance with regard to financial instruments and securities (other than equities) issued in the form of ledger-based securities, the Capital Markets and Technology Association ("CMTA") has created the "CMTA Tokenized Debt" and "CMTA Tokenized Debt (Program)" certification mark logos.

The following guidelines set out the specifications for use of the logos and Quick Response (QR) codes by certified companies.

Companies using the logo must have tokenized financial instruments in compliance with the CMTA's Standard for the tokenization of debt instruments using the distributed ledger technology and accompanying Certification Mark Regulations. The logos can only be used by companies that have been certified by the CMTA. The CMTA monitors ongoing compliance with the regulations.

The CMTA Tokenized Debt and CMTA Tokenized Debt (Program) logos have been registered with the Federal Institute for Intellectual Property.

CMTA Tokenized Debt and CMTA Tokenized Debt (Program) are certification marks, the use of which is defined by the provisions of these guidelines.

Usage of the **CMTA. Tokenized Debt** **Certification Marks**

CMTA will provide certified companies with the appropriate logo and QR code.

The logo and QR code shall not be edited and CMTA reserves the right to replace the certification logo and QR code at any time.

Companies authorized by the CMTA to use one of the certification marks are authorized to use the relevant logo outlined on page 4 of this document and must respect the specifications described on the following pages.

The graphic rules for the use of the logo must also be respected in marketing and advertising.

QR code verification

To allow the public to verify a company's certification status, CMTA provides a QR code which must be used alongside the CMTA Tokenized Debt logo.

The QR code is readable by widely available QR readers and directs viewers to an online version of the CMTA certification marks register of users which includes the name of the certified company, the scope of the certification given and its validity.




Visual identification through the symbol


